

# **JUNBPAW Power Inverter Limited Warranty**

Thank you for choosing JUNBPAW products. We are committed to providing high-quality inverters. As a testament to our confidence in product quality, we are pleased to offer the following limited warranty.

## **1. Warranty Coverage**

- Applicable Product Models: LGE-1080, LGE-2080, LGE-3080, LGE-1280, LGE-1080TI, LGE-2080TI, LGE-3080TI
- Geographic Validity: North America
- Warranty Period: 2 years from the original date of purchase.

## **2. Warranty Terms**

JUNBPAW warrants its products against defects in materials and workmanship under normal use and service conditions. This warranty is valid only for the original purchaser and covers only the unexpired portion of the warranty period. If the product is gifted or resold, warranty claims must be submitted by the original purchaser with valid proof of purchase (original order information).

## **3. Exclusions and Limitations**

This warranty does not cover:

- Improper operation or failure to follow installation/operation manual instructions.
- Unauthorized modifications, repairs, or the addition of attachments.
- Damage caused by misuse, accidental damage, vandalism, or animals.
- Use in unsuitable environments (e.g., insufficient ventilation, corrosive atmospheres, excessive dust/debris).
- Failure to comply with applicable safety standards and regulations.
- Damage from external factors beyond the product's designed tolerance (e.g., weather exposure, liquid ingress, fire, power surges, etc.).
- Damage occurring during shipping or storage.
- Damage resulting from force majeure events (e.g., fire, flood, earthquake).
- If JUNBPAW determines that a product failure is not due to a defect in materials or

workmanship, the user will be responsible for all costs associated with repair, replacement, and shipping. JUNBPAW is not liable for costs related to installation/removal, electrical system testing, loss of time, or any other incidental or consequential damages.

#### **4. Warranty Claim Process**

- Provide the original order information and a description of the issue. Our support staff will verify the details and guide you through the return or replacement process.
- Upon receiving the defective product, JUNBPAW will conduct an inspection. If the issue is confirmed to be covered under this warranty, we will provide free repair or replacement. Otherwise, the user will bear all related costs.
- The replaced/defective product becomes the property of JUNBPAW upon shipment of the replacement unit.

#### **5. Important Notices**

- Please inspect the product within 30 days of receipt. Claims for shipping damage must be made within this period, after which responsibility transfers to the user.
- Repaired or replaced products are covered for the remainder of the original warranty period; the warranty is not extended or renewed.
- JUNBPAW shall not be liable for any indirect, incidental, special, or consequential damages, including but not limited to loss of data, profits, or business interruption.
- To the extent permitted by law, JUNBPAW's total liability shall not exceed the purchase price paid for the product.
